Aim

Securing the supply and strengthening strategic positions related to critical and strategic raw materials (CSRMs), as well as the technologies dependent on them, are a top priority for many countries and are attracting political focus worldwide. At the same time, despite global geopolitical and geoeconomic tensions, safeguarding the raw material basis for a global clean transition is essential to support climate goals and ensure a sustainable future. Building upon previous initiatives, the International Round Table on Materials Criticality (IRTC) aims to convene international experts at an online Round Table to exchange approaches on identifying critical and strategic raw materials and strategies for secure, resilient and sustainable CSRM supply chains.

Purpose

The Round Table shall delve into recent advances in assessing and managing CSRMs on a policy level. As a key outcome of the Round Table, IRTC will coordinate the development of a White Paper in collaboration with the participating experts which will be published on the IRTC website and distributed in relevant channels.

Round Table content

Experts will present the approaches of their country or supranational entity on critical/strategic raw materials evaluation and policy developments for CSRM management. Audience participation and interaction during the event are highly encouraged. An interactive whiteboard will facilitate communication and exchange.

IRTC furthermore asks researchers and organisations worldwide to share the methodologies and approaches they are currently using or developing.
